Survey Data


- Total surveys processed: 254
- Men: 127

- Elected leaders: 76

- Graduated grade 12 and higher: 193

Important Notice

This survey relied on volunteer responses that were not controlled. The sampling of input was largely outside of CopperMoon's control, relying instead on First Nations to inform their members and solicit input. The data has some weaknesses including:


- The survey favours those who could afford to make a meeting and does not cover the most disadvantaged who are unemployed, etc.
- The majority of respondents are employed by a First Nation. This employed segment represents a minority of First Nations people.
- At 58, the average age of respondents is very high. The average age of First Nations in BC is closer to 25, and the majority of First Nations are under the age of 30. Only 15 of the 254 respondents were 30 or under (6%).
- 75% of respondents have graduated grade 12 or higher, and a majority would be considered educated, again this is not reflective of the population.
- The wording of some questions led to different interpretations and therefore varying responses. Specifically data from questions 4.6 (support research) and 5.2 (meaningful consultation) should be taken lightly as those questions could have been interpreted differently than intended.

Respondents by Region






Subjective Evaluation of Objectives

The objectives of the Trust in brief are:

- 1. Enhance Governance within First Nations Governments: Better local government, negotiation with Province, and civil service.
- 2. Develop the capacity of First Nations: Better development of professionals, education, language and culture, and health care.
- 3. Enhance management of First Nations lands and resources: Better land management, resource planning, economic use of land, and growth of capital.
- 4. Enhance the economic status of First Nations communities: More revenue sharing, economic development, and pre-treaty agreements.

Average Rating






Subjective Evaluation of Human Resources by Priority

Number of other types of training suggested: 65




Barriers






Survey of Post Secondary Educated FN People

Do you work in a First Nations community?


If you are a First Nations person, did you attempt to return to your home community after completing your diploma, certificate, or degree?

Are their job opportunities in your field of training in your community?


If Yes, did you feel supported returning to your home First Nations community for work after graduation?




Home Support

- Number that didn't respond: I4






















Limits on Funding

Should there be limits on how much funding is disbursed to each applicant?








Favor Proposals with Aboriginal Suppliers?

Should the Trust favor projects that have Aboriginal suppliers compared to those that don't?









Importance of Research and Yearly vs Multi-Year funding







